South East Suffolk Magistrates' Court, Ipswich

Craig Baker, 21, of Coronation Drive, Felixstowe, Obstruct / resist a constable, Assault a constable in Felixstowe, Guilty pleas – changed from not guilty, Community order – Attend Aggression Replacement Training, Supervised by the Probation Service for 18 months, 160 hours unpaid work, To pay compensation at South East Suffolk Magistrates' Court on 7 June.
