Minutes of the Meeting held on Thursday 16th September 2010 in Polstead Village Hall

Present: Cllrs Nick Brandt (Chairman), Michael Hackford and Anne MacWilson.

Attending: Sue Wigglesworth (Babergh District Councillor), David Yorke-Edwards (Suffolk County Councillor, Dave Crimmin (Clerk) and 35 residents.

10/132 Apologies for Absence

Apologies received from Cllrs Baxter, Flather, Kilshaw and Ravensdale.

10/133 Declaration of Interests

None were declared.

10/134 Minutes of Meeting held on 15th July 2010

The minutes of the meeting were approved and signed by the Chairman as a correct record.

In light of the public interest in the new Bus Timetable on the Agenda, the councillors resolved in accordance with Standing Order 15 to vary the order of business for this item to be discussed next.

10/135 New Bus Timetable

The introduction of the new bus timetable on the 31st August had meant that the only option for travel to Colchester was before 8am and returning late in the day and a trip to Hadleigh meant arriving there early evening and return next day. PPC considered that these services were totally inappropriate for Polstead residents and the Chairman outlined the actions taken by PPC after being notified of the changes by disgruntled residents:

- On the 6th September the Chairman hand delivered PPC's letter outlining its concerns with the bus service to the Chief Executive of Suffolk County Council, Jeremy Pembroke, Leader of SCC and Polstead's Suffolk County Councillor David Yorke-Edwards
- On the 7th September Philip Magill, SCC's Transport and Procurement Transport Manager, invited PPC to attend a meeting on the 8th September
- The Chairman, Rita Gillham and the Clerk met Philip Magill at Endeavour House and after agreeing that the service provided to Polstead was inadequate, they reviewed the Community Transport options that were now to be made available to Polstead residents
- It was agreed that SCC would send Derek Cocker, its Demand Responsive Transport Manager, to attend this meeting to review with residents the options available under the Community Transport scheme
- The meeting notice placed on the notice boards and website invited residents to attend this meeting if they used the bus services.

With 25 residents attending the meeting to discuss the options available with Derek Cocker it was agreed that they should go to Mrs Jill Lowe's house to discuss the options outside the constraints of the Parish Council meeting. The councillors were very grateful for Mrs Lowe's offer.

10/139 Report from Bus Shelter working group

10/140 Planning

- a. The councillors reviewed Planning Application **B/10/00935 Polstead Green Cottage, Polstead Green** for the erection of single-storey rear extension and resolved that they positively supported the application.
- b. The councillors reviewed Planning Application **B/10/01027 Woodfield, Stackwood Road, Hadleigh Heath** for the erection of detached double garage and resolved that they had no objections
- c. The councillors reviewed Planning Application **B/10/01026 Land between The Oaks and Millfield Wood, Heath Road** for the erection of grain store with construction of hard standing and vehicular access to Heath Rod and resolved to object strongly to the application and expressed the following concerns:
 - The proposed field is not part of an adjoining farm and is in the middle of a residential area
 - The access road to the site is poor in terms of its ability to accommodate large vehicles
 - The volume and type of traffic identified by the application is considered to be totally unsuitable for the access road and nearby dwellings
 - The development will increase the severe drainage problems that already exist along the access road
 - Noise pollution will be generated from the site by both the extra vehicular movements and machinery in the grain store.
 - Should the application be approved driers could be subsequently be requested to be installed in the grain store
 - The site will produce light pollution in the neighbourhood
 - The proposal is for storage of grain that is not grown locally and will be transported to and from the location with no extra employment being generated locally
 - The field is an important open space in the area
 - Appendix 2 of the Design & Access Statement does not identify the application site as the one being given approval by Mrs Hall.

The councillors asked Sue Wigglesworth to request a site meeting of BDC's Development Committee so that the residents and councillors concerns can be reviewed.

- d. The councillors reviewed Planning Application **B/10/00921The Cottage, Mill Street - LBC** for alterations to west-facing window (serving the kitchen); erection of replacement window to north elevation; erection of replacement front door; and erection of replacement flue exit pipe with a condensing boiler and resolved that they had no objections.
- e. The councillors reviewed Planning Application **B/10/0/1086 Charlotte Bungalow, Bower House Tye** for the erection of a single-storey side extension.and resolved that they had no objections.
- f. No further planning application had been received by the council since the agenda was posted.

In light of the importance of the Babergh Development Framework consultation on the Agenda, the councillors resolved in accordance with Standing Order 15 to vary the order of business for this item to be discussed next.

10/141 Babergh Development Framework

Sue Wigglesworth had updated the councillors that at this draft consultation stage of the BDF, Polstead has been identified as being "semi-sustainable" and that it would be earmarked for additional housing in the future if this was verified at the approval stage.

The Chairman and Cllr Hackford will represent PPC at the BDC's workshop at Bildeston on 13th October and report back to the next meeting. There is space for one more councillor at the workshop if required.

10/142 Finance

- a. All cheques signed and due for signing, as itemised in Appendix B, were authorised by the councillors. The councillors also noted the income received since the last meeting and reviewed the Statement of Accounts against the budget and the Bank Statements against the reconciliation. The councillors resolved that the £1,316.80 received from the Polstead Playground Group should be placed in the earmarked reserves for maintenance of the playground equipment.
- b. The councillors resolved to make a further donation of £72 to Hadleigh Fishing Club (HFC) with regard to junior members' membership in 2010.

Appendix A County, District and Suffolk Constabulary reports and Public Forum

PCSO Amanda Coleman reported that there have been 2 reported crimes since the last meeting on the 15th July. "Sometime during the late evening of 23rd July a mobile phone was taken from the bar area of the public house. A male person was suspected however there was not enough evidence and there has been no further action. During the hours of darkness on the 9th September at Bower House Tye a person has pointed a laser light at the police and RAF helicopters. There is a male suspected of this crime and we are awaiting the outcome of any arrests. PC Chris Garrod has now been posted to Sudbury and we will be getting another PCSO Mel Cohen (nee Galyean) but at this stage I do not have her starting date." David Yorke-Edwards updated the meeting that everyone at SCC is busy with the financial targets being set by the new government. He also updated councillors on the Locality Budget currently available to PPC Sue Wigglesworth outlined the process surrounding the Babergh Development Framework consultation that BDC were about to undertake. She feels that the BDC / Mid Suffolk merger was proceeding at a pace which was not sustainable. She feels that one district council will be achieved but this could be completed in a timescale ranging from 1 to 5 years. She highlighted the merger of the Revenue and Benefits system by BDC, MSDC and Ipswich Borough Council as a sign of things to come. Resident issues relating to the grain store planning application were also discussed.
