

# POLSTEAD PARISH COUNCIL

## Minutes of the meeting held on Thursday 17<sup>th</sup> September 2009 in the Village Hall Polstead.

- 1) **Apologies for Absence:** None
- 2) **Declarations of Interests:** None.
- 3) **Minutes of the Meeting 16<sup>th</sup> July 2009:** The Minutes were previously circulated. & agreed & signed.
- 4) **Minutes of the Planning Meeting 13<sup>th</sup>. August 2009:** The minutes were read, agreed & signed by the Chairman as being accurate
- 5) **Reports:**

**A) County Councillor**

David Yorke-Edwards reported that the District Councils Hearing was to be held on the 6<sup>th</sup>/7<sup>th</sup> October. He also reported on the National Grid proposals for the power lines across the county.

**B) District Councillor.**

Sue Wigglesworth thanked the council for its support in the planning objection. Also she reported that the Babergh Core Strategy had reached its final consultation period. Sue also reported cuts in government funding

- 6) **Suffolk Constabulary:** Nick Brandt reported that following the report of damage at or concerned with the Polstice he had not had any success in getting information from Suffolk Constabulary as to what or who was concerned. There was no Police Report, but David Yorke-Edwards reported that a police inspector had reported to him that a police presence at a Parish Council meeting could only be expected about twice a year. The Chairman responded that twice a year would be a n improvement on the current track record!
- 7) **Reports from Councillors:** Richard Kilshaw reported that the wall at the bottom of the hill on the bridge had been repaired and that the drain at the bottom of the hill / pond was once again blocked. Also that the drainage generally about the village needed clearing. (Sue Wigglesworth is to take the drain at the pond up with Babergh). Richard also reported that the playing field insurance is due soon.

- 8) **Planning:** It was reported that the planning applications for:

- B/09/00567/FUL - D'Arcy Cottage, had been refused
- B/09/00779/FHA - Charlotte Bungalow, had been approved
- B/09/00556/FHA - 19 Rockalls Road, had been approved

#### **9) Financial Matters:**

The attached sheet was circulated before the meeting,  
The Chairman reported that Babergh had paid the Council £200 compensation for the problems that had occurred with the precept payments.

#### **10) Highways & Footpaths:**

The Chairman reported on the proposed footpath Rockalls Road to FP35, that he had had a letter regarding it but there was still no mention as to who was to pay for the clearance of it or the proposed gateway. Michael reported a water leak in Stackwood Road. The Chairman is to ring Anglian Water about it.

#### **11) Hog Roast:**

Ck Brant reported that he has the white wine and soft drinks.  
Dylan Pymm has the beer on order. The bill has to be paid by the Council

The marquee to be collected by Richard Kilshaw and Michael Hackford and be erected on Friday night All volunteers required. The bar to be set up on Friday night . Staff to be available as early as possible on Saturday morning. Bar prices to be displayed on a sign. Wheely bins to be used for rubbish bins Richard & Nick to supply them with bin bags.

The generator, diesel and portable toilets all confirmed by Michael.

Music / bands booked, less raucous than last year as requested.

The question of a BBQ for later was raised& agreed. Michael to supply the BBQ itself Nick to supply sausages & charcoal. Ketchup & mustard to be supplied by Mandy?

#### **12)Carse Pond:**

Richard Kilshaw reported that he had a letter from the Pond Society who need to know what it is current used for. Richard has dug some sample pits & found no liner. John Baxter stated that he believes that Highways probably removed it years ago. Sue Wigglesworth suggested The Dedham vale Society for funding. Nick Brandt to write to Mr John Boucher inviting him to a site meeting to access what we can do.

#### **13) Bus Shelter**

Nick Brandt reported that there had been no response to his letter to County on any topic.

#### **14) National Grid Proposals:**

The Council was advised about the proposals of the National Grid, But decided to save response until the consultation documents arrive.

**15) Correspondence:**

The topic was raised on Babergh's Affordable Housing meeting, But it was decided that it was not applicable to the Parish Council and not to attend.

The Community Achievement Awards was mentioned and a suitable candidate was proposed by Michael Hackford, seconded by Mandy Flathers.

A cheque to P&H Landscapes from the Council had been bounced by the bank as not signed in accordance to mandate.

The Chairman was trying to contact P&H to try to explain that it was not our fault, and to contact the bank to get an explanation.
